1. Seller agrees to sell, and Buyer agrees to buy electrical goods, services and labor associated with the installation and maintenance of said goods.
2. The parties agree that the terms of this agreement shall apply to, and are incorporated (with or without specific references) in any transaction by and between Seller and Buyer from and after date of full execution of this agreement.
3. Except as provided in this agreement, each separate transaction of sale between the parties will be governed by its own terms and conditions.
4. In the event that Buyer fails to pay when due the purchase price of any goods or services from the Seller, then interest shall accrue on any past due balance at the rate of eighteen percent per year (1.5% each month) or the higher lawful rate of interest under North Carolina law, whichever is less. In the event Seller refers any delinquent accounts of Buyer to an attorney for collections, Seller shall be entitled to recover its attorney fees (if allowed by North Carolina law), courts costs and all other costs associated with the collection efforts of Seller from Buyer. This agreement is deemed executed in Iredell County, North Carolina, is governed and construed by and under North Carolina law and the only forum of litigation, if any, shall be Iredell County, North Carolina.
